



PREVIOUS APPOINTMENTS AND NEW APPOINTMENTS for renewal of residence permits

The Police Headquarters of Bologna from Monday 18 May reopened the accesses: for the ADMINISTRATIVE SECTOR the already scheduled Cupa appointments - NON POLITICAL ASYLUM - (e.g. medical treatment, art.31, family reasons and cohesion of Italian citizens) at counter 1 , have been rescheduled as per attachments verifiable on the site:

<https://questure.poliziadistato.it/it/Bologna/article/21535ebd1fef877a931051801>; **the rescheduling is as follows:** from April 14 to May 18; from April 15 to May 19 and so on, respecting the same time of the previous appointment. **The appointments scheduled in April had already been postponed** by sms or email.

- **For the appointments for photographic identification that had been already fixed**, it is necessary to check the new appointment on the portal: <https://www.portaleimmigrazione.it> ; **the new appointments will start from next June 16th**; Poste has already done so or will communicate the new date if it has not already been communicated. It will be necessary to check if no message has been received or if there has been a change of mobile phone.

- **For the delivery of residence permits for work**, awaiting employment, etc ... it will be necessary to make a new reservation through <https://www.questura.bologna.it>.

- For the **POLITICAL ASYLUM sector: 1st access has never stopped**;

• **holders of residence permits for asylum applications**, pursuant to Law no. 27/2020 expiring between 31 January and 31 July, **are extended for validity until 31 August 2020**; therefore the appointments already booked through the Cupa Project agenda have been canceled; **the RENEWAL of asylum request permits must be rebooked on the website:** www.cupaproject refugee sector; POLITICAL ASYLUM;

• **only those who have a provisional residence permit** issued at the time of verbalization of the application and those who have a residence permit for "asylum request" **expired before January 31, 2020**, can make a new appointment on the Cupa Project website: <https://cupa-project.it/> by accessing the area POLITICAL ASYLUM - Renewal of residence permit for asylum request.

For the appointments of the Italian tests already booked: the tests set from February 28th onwards have not yet been rescheduled, therefore it will be necessary to wait for new provisions.
